

BMW / MINI BEV Battery Certificate for the High-Voltage Battery

– Terms and Conditions

The BMW / MINI contract partner grants the purchaser of a new BMW / MINI BEV vehicle the following benefits with respect to the High-Voltage Battery in addition to the warranty rights pursuant to the Terms and Conditions for new BMW / MINI vehicles:

1. The BMW / MINI Battery Certificate for the High-Voltage Battery of a new BMW / MINI BEV vehicle applies for the first **160.000 kilometers** and ends, regardless of the actual mileage [kilometers] driven, **eight years** after the first delivery or the initial registration of the new BMW / MINI BEV vehicle, whichever is the earliest ("Certificate Period").
2. Within the Certificate Period, the purchaser can claim the repair of a technical defect concerning the High-Voltage Battery free of charge.
3. Should it become necessary to recover the BMW / MINI BEV vehicle within the Certificate Period due to a technical defect, the necessary costs for towing to the nearest BMW / MINI service workshop will be refunded to the purchaser.
4. The purchaser may claim the benefits specified in this BMW / MINI BEV Battery Certificate at every BMW / MINI BEV service workshop.
5. Subsequent vehicle owners of the BMW / MINI BEV vehicle are also entitled to all benefits specified in the BMW / MINI BEV Battery Certificate.
6. To enjoy the benefits outlined in this BMW / MINI BEV Battery Certificate it is mandatory that all vehicle inspections are carried out in the intervals as specified by the manufacturer and checks and rectifications of the High-Voltage Battery are performed where necessary during those inspections. The purchaser shall not be entitled to claim the benefits specified in this BMW / MINI BEV Battery Certificate if a technical defect or excessive capacity loss was caused by an accident or one of the following reasons:
 - The BMW / MINI BEV vehicle was operated under conditions for which it was not homologated for (e.g. in a country with different homologation regulations to the one it was originally delivered in).
 - The BMW / MINI BEV vehicle was operated abnormally or overstressed, e.g. at competitive motor sports events.
 - Parts have been fitted to the BMW / MINI BEV vehicle which were not approved by the manufacturer or the BMW / MINI BEV vehicle or parts of it (e.g. software) have been manipulated in a way that was not approved by the manufacturer.
 - The instructions on use, maintenance and care of the BMW / MINI BEV vehicle (especially according to the owner's manual) have not been followed.
 - The High-Voltage Battery has been opened or removed from the BMW / MINI BEV vehicle.
7. This BMW / MINI BEV Battery Certificate supplements the Terms and Conditions for new BMW / MINI BEV vehicles. Benefits and rights pursuant to the Terms and Conditions for new BMW / MINI BEV vehicles shall remain unaffected by this BMW / MINI BEV Battery Certificate.
